The Hollidaysburg Pumpkin Festival will be here before we know it! There is a \$10 registration fee per vendor. Each space measures approximately 18 ft. wide x 7 ft. deep. Easy-up tents are recommended, as are weights to secure the tents. In order to avoid duplications, and to ensure that vendors' electrical needs can be met, all vendors must register by September 3, 2010. The registration fee is due at time of registration. HCP will contact you if your choice of fundraiser has already been chosen, and we will help you with other food and/or activity ideas.

To guarantee your space, registration forms and fees must be received by Friday September 3rd. Your space number assignment and festival map will be mailed to you on or before October 2nd.
